## **PLEASE READ ALL INFORMATION**

### **COLLECTION DATES at the Town Hall:**

Wed, Dec 23 – 5 to 7:30PM	Wed, Dec 30 – 5 to 7:30PM	
Tues, Jan 19 – 5 to 7PM	Thurs, Jan 21 – 5 to 7PM	Sat, Jan 23 – 9 to 11:30AM
Tues, Jan 26 – 5 to 7PM	Thurs, Jan 28 – 5 to 7PM	Sat, Jan 30 – 8 to 11:30 AM

*\*\*\*Please bring a check, money order, escrow check or the correct amount of cash. I will not have change and no checks for overpayments will be issued at that time.*

**PAYMENT INFORMATION: THE STUBS at the bottom of statement(s) MUST ACCOMPANY PAYMENT.** Payments can be mailed, dropped off in lock-box outside of the Town Hall front door, or brought to the Hall during collection dates shown above. **MAKE CHECKS PAYABLE TO “TOWN OF ARCADIA TREASURER”.**

If you need your payment receipted for 2015, your check must be dated and/or postmarked no later than 12/31/2015, and MUST ARRIVE AT THE TOWN HALL NO LATER THAN JANUARY 3<sup>rd</sup>.

**PAYMENT BY MAIL – On or before January 31, 2016** - All or first half of your taxes may be mailed to address shown below. To receive proper credit, all payments **must be postmarked no later than January 31, 2016**, and MUST ARRIVE AT THE TOWN HALL BY Feb 3, 2016.

**PERSONAL PROPERTY TAXES** - Must be paid in full on or before January 31, 2016. All delinquent personal property taxes will be subject to 12% interest APR.

#### **IF PAYING IN CASH – MUST BRING CORRECT CHANGE**

If you choose to pay your tax in full

If you choose to pay in two installments:

1<sup>st</sup> installment due to local treasurer at above address by January 31, 2016  
1<sup>st</sup> installment

2<sup>nd</sup> installment due to **TREMPEALEAU COUNTY TREASURER** by July 31, 2016 (note: no reminder notice will be sent) at P O Box 67, Whitehall, WI 54773  
2<sup>nd</sup> installment

**Note: It is your responsibility to forward the tax bill to the new owner if you sold your property during the year.**

TOWN BOOKLETS with tax information will be ready before the end of February and will be available for pick up at the Town Hall during normal business hours. The 2015 annual financial statement will be completed before the Annual meeting.

**NOTE: Dog licenses obtained after March 31, 2016 WILL be charged at extra \$5 per license (mandated by the State).**

- ❖ Office hours for the Town Clerk are Mon/Tues 9 to 5; Wednesday 9 to Noon; Thurs 9 to 6. You can also contact the Town office at 608-323-3470 or e-mail the clerk at [townofarcadia@outlook.com](mailto:townofarcadia@outlook.com).

- ❖ The Trempealeau County Times is the paper that will be used if a legal notice is required to be published.
- ❖ The agenda for Town meetings is posted on the bulletin board at the Town Hall at least 24 hours prior to the meeting. To appear on the agenda contact the clerk a week prior to the meeting date.
- ❖ Reminder - building inspection permits are needed for any building projects. Forms can be found on the Trempealeau County website ([www.tremplocounty.com](http://www.tremplocounty.com)), and must be signed by a Town of Arcadia Board Supervisor.
- ❖ If you would like to reserve the Town Hall for an event, please call the Clerk/Treasurer or Deputy Clerk/Treasurer at 608-323-3470.
- ❖ Please keep parked cars and equipment off the streets and roads during the winter to allow for easier snowplowing.
- ❖ Remember to be a good neighbor - Keep your pets in your own yard and quiet barking dogs.
- ❖ If you need a burning permit please contact the Sheriff's office.
