## Town of Arcadia Minutes of Regular Board Meeting Monday, November 4, 2013 at 8:00 a.m.

The board meeting was called to order by Chairman Ronald Tuschner at 8:02 a.m. Open meeting certifications were met. Roll call was taken. All Board members were present: Chairman Ronald Tuschner and Supervisors Michael Wineski and Ivan Pronschinske. Also present were the attached list of residents.

A motion was made by I. Pronschinske and seconded by M. Wineski to adopt the agenda. The motion was carried unanimously with a voice vote.

A motion was made by M. Wineski and seconded by I. Pronschinske to approve the minutes of October 21, 2013. The motion was carried unanimously with a voice vote.

A motion was made by I. Pronschinske and seconded by M. Wineski to approve disbursements of November 4, 2013. The motion was carried unanimously with a voice vote.

At 8:04 a.m. R. Tuschner opened the floor to public comments for other topics that were not listed on the November 4, 2013 agenda. Mr. Losinski was the only one present, and he was speaking on an item listed on the agenda. There were no other comments from the public. R. Tuschner closed the public comments at 8:05 a.m.

### **Request by Bob Losinski to add to the Town Road of Losinski Lane**

There was a request made by M. Wineski to move this item of the agenda first. Bob Losinski asked for the Town of Arcadia to extend 100 feet to the Town Road. It is not currently blacktopped. B. Losinski plans to blacktop it in the spring. Discussion followed concerning the current condition and blacktopping of the road. A motion was made by I. Pronschinske and seconded by M. Wineski to extend the road as suggested and blacktop it in spring by the property owner. The property owner would convey over legally the road to the Town of Arcadia. Once the road is blacktopped the Town of Arcadia would take it over and maintain it. Discussion continued on the agreement with the understanding that the Town of Arcadia would officially accept the road and maintain it after it is blacktopped, which may take a period of time. The motion was carried unanimously with a voice vote.

### **Garbage/Recycling Procedures**

B. Killian stated that Bob Sonsalla is researching the sticker ideas discussed previously. Ana McCabe from the DNR was at the Town of Arcadia Office. She visited B. Sonsalla and his operation before meeting at the Town Office. Discussion followed about his operation, suggestions to add a noncompliance policy and to add to the tax bills the items that can be recycled, and the procedure for setting up a program at the Town property.

### **Westland Insurance Quote for the Town of Arcadia's Insurance**

The representative was not present. No action taken.

### **Rural Insurance Quote for the Town of Arcadia's Insurance**

Gretchen Erickson had called. She needs more time to split the quotes. She requests to be on the next agenda.

### **Local Government Property Insurance Quotes**

Different quotes were in the packets. Last year's payment was made. This year's payment is due on February 19, 2013. A resolution is needed if we no longer wish to use this Insurance. This will be on the next agenda.

### **Purchases of Culverts**

This will be on the next agenda.

### **Approve the Proposed 2014 Budget**

Discussion was held on the budget; the copy that will be printed in the Trempealeau County Times; budgets of other Towns in the area; the special town meeting; expenses and income; and the worksheet used at the budget meetings. The Clerk was instructed to add another column to the worksheet to show the actual expenses up to October 31. A motion was made by M. Wineski and seconded by I. Pronschinske to approve the proposed budget. The motion was carried unanimously with a voice vote. Discussion continued about amending this budget in the future, FEMA money, tax cuts, Angus Andre bridge, KGB and other roads shut down because of the emergency, 2010-2012 projects completed because of emergencies, FEMA money requested and actually received, and items from the past 5 years for the special meeting.

### **Set November 26, 2013 at 8:00 p.m. as the date for a Special Budget Meeting to exceed the levy limits**

Discussion was held about the procedure for the Special Budget Meeting and the Budget Hearing and the posting. A motion was made by M. Wineski and seconded by I. Pronschinske to set the Special Budget Meeting to exceed the levy limits for November 26, 2013 at 8:00 p.m. and the Budget Hearing immediately following. The motion was carried unanimously with a voice vote.

### **Set November 26, 2013 at 8:30 p.m. as the date for the Budget Hearing**

Motion was just made in the previous item.

### **Approve a 300 Foot SBA & Verizon Wireless Tower on the Nancy and Dan Filla Property**

Discussion was held about the location. A motion was made by M. Wineski and seconded by I. Pronschinske to approve a 300 foot SBA & Verizon Wireless Tower. The motion was carried unanimously with a voice vote.

**Correspondence:**

A notice of public hearing on November 13, 2013 will be held by the Trempealeau County Environment and Land Use Committee for the amendment of County Comprehensive Zoning Ordinance. WWTC sent the 2014 levy limit total of \$383,649.87. Discussion was held about the levy limits from other entities. A letter and fax came about the Suspension of the 2014 Boundary and Annexation Survey. Mr. Tuschner will check into this.

Discussion was held about the next meeting date and time. A motion was made by M. Wineski and seconded by R. Tuschner to set the next regular Town of Arcadia Board meeting for Monday, November 18, 2013 at 7:00 p.m. Motion was carried unanimously with a voice vote. Agenda items were discussed. A list is in the office. Discussion was held about the budget and having an additional meeting. A motion was made by R. Tuschner and seconded by M. Wineski to have a budget meeting on November 8, 2013 at 7:00 a.m. The motion was carried unanimously with a voice vote.

R. Tuschner adjourned the meeting at 8:57 a.m.
